Description

Staphylococcus aureus subsp. *aureus* strain Seattle 1945 is a whole-genome sequenced clinical isolate. This culture is used as a quality control strain for the CAMP test, assay of wood smoke concentrate, evaluation of Mueller-Hinton agar, examination of dairy products, media testing, CLSI disk diffusion, and for Abbott, and Autobac products.

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0

- mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24 hours.

It is advisable to transfer from agar to agar to maintain MIC values.
