## **Description**

*Vibrio campbellii* strain BB151 is a mutant derived from *Vibrio campbellii* strain BB120 (ATCC BAA-1116). This whole-genome sequenced bacterial strain produces beta-hydroxybutyryl homoserine lactone (A1-1) and an unidentified autoinducer (A1-2). This strain has genotype luxA::Tn5lac.

## Handling Procedures

1. Open vial according to enclosed instructions.

2. Using a single tube of #2034 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
  5. Incubate all tubes and plate at 30°C for 24 hours.
