Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

1. Open vial according to enclosed instructions.



- 2. Using a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for 24 hours in atmosphere of 5% CO<sub>2</sub>. Loosen the screw caps during the incubation.

## Notes

On #260 plates colonies are entire, glistening, circular, smooth, flat, and exhibit  $\alpha$ -hemolysis.
