1. Thaw Pluripotent Stem Cell SFM XF / FF complete medium at 2°C to 8°C overnight. The thawed medium is stable for up to two weeks at 2°C to 8°C.
2. Warm medium for NOT MORE THAN 30 minutes in a 37°C water bath prior to use.

*Pluripotent Stem Cell SFM XF/FF is stable for up to two weeks at 2°C to 8°C.*

**Note:** *It is recommended to prepare single use aliquots of the medium to prevent repeated warming at 37°C. If medium is not to be used within two weeks, it is acceptable to store aliquots at -20°C.*
