Description

Vibrio campbellii strain MM32 is a whole-genome sequenced bacterium that was derived from Vibrio campbellii strain BB120 (ATCC BAA-1116). This culture is one of several strains included in a "quorum sensing kit" (ATCC MP-6) developed by the depositor. This strain has the genotype luxN::Cm, luxS::Tn5Kan. It is a mutant sensor strain that is a non-self-stimulating reporter for autoinducer Al-2.

ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #2 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #2 agar slant, and/or plate.
- 5. Incubate all tubes and plate at 30°C for 24 hours.

Notes

When using this strain as part of the "quorum sensing kit" or in any other bioluminescent assays, #2746 media should be used. Marine media contains boric acid and may cause otherwise bioluminescent-negative strains to luminesce, as boron is a key element in autoinducer-2.
