Handling Procedures

- 1. Open vial according to enclosed instructions.
- Using a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 24 hours in atmosphere of 5% CO₂. Loosen the screw caps during the incubation.

Notes

Colonies on #260 plates are flat, entire, glistening, smooth, and α -hemolytic.
