ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate additional #3 broth tubes, a #3 agar slant, and/or plate.

5. Incubate the tubes and plate at 37°C for 24 hours.

#### Notes

Colony morphology on #3 agar is circular, translucent, raised, glistening, smooth, and entire.

Cells are gram negative motile rods that appear in singles and pairs. This strain was confirmed by PCR to carry the *eae* and *stx*1 genes (*stx*1+, *stx*2-, *eae*+). Additional information on this culture is available on the ATCC<sup>®</sup> web site at www.atcc.org.
