### **Description**

Escherichia coli strain 2002-3211 is a whole-genome sequenced strain that was isolated in Virginia from stool. It is toxigenic and is positive for the eae and stx2 genes and negative for the stx1 gene. This strain is serotype O121:H19 and has applications in enteric disease research and food testing.

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for 24 hours.

#### Notes

This strain was confirmed by PCR to carry the stx2 and eae genes (stx1-, stx2+, eae+). Additional information on this culture is available on the ATCC $^{\otimes}$  web site at www.atcc.org.
