Description

Escherichia coli strain O111 is a whole-genome sequenced bacterium that can be used in enteric disease research, food testing, and infectious disease research. This strain is typed as serotype O111 and it is confirmed by PCR to contain the *eae*, *stx1*, and *stx2* genes.

Handling Procedures

BAA-2440

1. Open vial according to enclosed instructions.
 2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24 hours.

This strain was confirmed by PCR to carry the *eae*, *stx1*, *stx2* genes (*stx1+*, *stx2+*, *eae+*)
