This pair of products includes two plasmids: pENTR_L1L2_LitR -VP64 contains an ATCC® synthetic activator, LitR -VP64, (ATCC SB-1098®) and pENTR_L4R1_LitR - pCYC1MIN contains an ATCC® synthetic promoter, LitR -CYC1MIN, (ATCC SB1059®). They are two of DNA parts in the ATCC® Synthetic Biology Yeast Tool Kit for building gene circuits in yeast, *Saccharomyces cerevisiae*. Handling Procedures

Before opening the vial, centrifuge at 6,000 x g for 30 seconds. Add 30 µL of Molecular Grade Water and incubate the vial at 4°C overnight to dissolve the DNA. Each vial contains 2-3 µg plasmid DNA (measured by PicoGreen® dsDNA quantitation assay).
