## Propagation

### Medium

ATCC® Medium 2107: Modified Reinforced Clostridial Agar/Broth Medium (pre-reduced)  
ATCC® Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

### Growth Conditions

**Temperature:** 37°C

**Atmosphere:** Anaerobic gas mixture, 80% N<sub>2</sub>-10% CO<sub>2</sub>-10% H<sub>2</sub>

### Propagation Procedure

1. Open vial according to enclosed instructions.
2. Under anaerobic conditions, withdraw 0.5 mL of #2107 from a single test tube (5 to 6 mL) and rehydrate the entire vial contents.
3. Aseptically transfer this aliquot back into the broth tube. Additional tubes may be inoculated with 0.5 mL each from the suspension. A slant of #2107 may also be inoculated with 0.2 mL. Streak several blood plates to check for colony morphology and purity.
4. Incubate tubes under an anaerobic atmosphere at 37°C. Incubate one agar plate anaerobically for colony formation, and one aerobically for aerobic contamination check.

### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

## Notes

Anaerobe Systems Brucella Blood plates (AS-111 or AS-141) can be used to analyze colony morphology and purity.

Two colony types observed on Brucella agar are 1) large, grey, rough, lobate, irregular, and flat; and 2) whitish, irregular, smooth, raised, and undulate.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions.
