**Propagation Host:**

*Aedes albopictus* clone C6/36 cells (ATCC® CRL-1660™)

**Effect on Host:**

CPE, refractile rounding and sloughing

**Medium:**

EMEM (ATCC® 30-2003™) + 5% FBS (ATCC® 30-2020™)

**Growth Conditions**

**Temperature:** 28°C

**Recommendations for Infection:** Plate cells 18-24 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g., 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g., 0.01). Adsorb 1-2 hours at 28°C in a humidified, air atmosphere incubator. End adsorption by adding virus growth medium.

**Incubation:** 6-8 days at 28°C in a humidified, air atmosphere incubator, until CPE is progressed through 80% of the monolayer.

### Comments

Derived by adaptation of egg culture product ATCC® VR-331™ to *Aedes albopictus* clone C6/36 cells (ATCC® CRL-1660™). ATCC® VR-331™ and ATCC® VR-1853™ have not been compared for sequence or infectivity in egg culture and tissue culture.
