Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

1. Open vial according to enclosed instructions.
- 2. Using a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
- 4. Use several drops of the suspension to inoculate a #527 agar slant and/or plate.**

5. Incubate the tubes and plate at 26°C for 7 to 10 days.

## Notes

On #527 plates, aerial mycelia are a light, grayish-pink. Substrate mycelia are a deep yellowish-brown.
