Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## **Handling Procedures**

1. Open vial according to enclosed instructions.
2. Using a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or glass pipet. Rehydrate the entire pellet.
3. Transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a second tube of broth, one or

two slants and/or a plate.

5. Incubate all tubes and plate at 26°C for 3 to 7 days.

### **Notes**

On #196 agar, aerial mycelium is very pale yellow and substrate mycelium is gold.

Spores are held primarily in straight to flexed chains (rectiflexibiles). Spore chains hold 10 to 50 spores each and have a distinctive striated appearance.
