### Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or glass pipette. Rehydrate the entire pellet.
3. Transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a second tube of broth, one or two slants and/or a plate.

**5. Incubate all tubes and plate at 26°C for 72 hours.**

**Notes**

On #196 agar, aerial mycelium is initially white becoming gray within 7 days. Substrate mycelium is dark brown in the center of most colonies and orange brown on the edges. Spores are held in straight to flexed chains (rectiflexibiles) with 1 to 10 spores per chain.
