Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #265 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate an additional broth tube, a #265 agar slant and/or a plate.

5. Incubate all tubes and plate at 37°C for 24 hours.

Notes

Colonies on #265 plates are smooth, glistening, slightly irregular, translucent, and gray. This strain will grow on most routine medium, but #265 is recommended for phage propagation.
