Streptococcus agalactiae grouping strain O90R [E. Todd strain Aronson Wamoscher] is a whole-genome sequenced bacterial strain. The product is in Lancefield's group B and can be used as a control strain for Group B *Streptococcus* (GBS). It also has applications in media testing.

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24 hours.
