Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #416 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well
4. Use several drops of this suspension to inoculate a second tube of broth, a

slant and/or a plate.

5. Incubate tubes and plate at 37°C in an atmosphere of 5% CO₂ for 24 to 48 hours. Loosen screw caps of all test tubes during the incubation period.

Notes

Colonies on #416 agar are entire, glistening, circular, smooth, and raised.

The CO₂ is not necessary for growth but may enhance it.
