Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #151 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #151 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 7 to 14 days

### **Notes**

**Establish growth first in broth tubes for one to two weeks before transferring to agar plates.**

Colonies on #151 agar plates are irregular, dull, rough, raised, and slightly rhizoid. The aerial mycelium is light to medium white, and substrate mycelium is ivory.
