ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Handling Procedures

1. Open vial according to the enclosed instructions.
2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a second #260 broth, #260 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 24-48 hours.

Notes

On #260 plates, colonies are entire, circular, smooth, convex, and exhibit beta hemolysis. The cells are short, non-motile rods that are Gram negative.
