## Handling Procedures

- 1. Open vial according to the enclosed instructions.**
  - 2. Using a single tube of ISP #1 broth (5 to 6 ml), withdraw approximately 0.5 ml to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.**
  - 3. Aseptically transfer this aliquot back into the broth tube and mix well.**
  - 4. Use several drops of the cell suspension to inoculate a second tube of broth, a slant and/or a plate.**
  - 5. Incubate all tubes and plate at 37°C for 48-72 hours.**

Vegetative cells have an irregular edge and a smooth, heaped folded center. Pigmentation of the vegetative cells is medium to dark pink on ATCC #196, ISP 2 medium. The strain does not produce aerial mycelium or a soluble pigment.
