Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

1. Open the vial according to the enclosed instructions.
2. Using a 1.0 mL pipette, withdraw 0.5 mL from a tube containing 2.5 mL. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the tube. Mix well.
4. Make serial dilutions by transferring 0.25 mL from the original tube to a tube containing 2.25 mL. Repeat process by transferring 0.25 mL from the second to a third tube, etc. Dilutions are important, not only for titration purposes, but

also to keep culture in varying stages of growth. Many strains will die out rapidly once acid or alkaline conditions are reached. It is recommended to prepare several dilutions from the initial tube as the cryoprotectant used in the freeze drying process often inhibits growth.

5. Use an uninoculated tube of broth to serve as a control.
  6. Plates may be inoculated to check colony morphology. You can also spot each dilution on the surface of plate to determine the number of colony-forming units.
  7. Incubate all tubes at 37°C aerobically and the plates at 37°C in 5% CO<sub>2</sub>. This strain shows turbidity in the first few dilution tubes within 24 hours. Additional incubation is required for growth on solid medium.
  8. Subsequent fresh transfers grow more rapidly than the original rehydrated culture. This strain produces good turbidity.
