## Growth Conditions

**Medium:**

ATCC Medium 543: Rhodopseudomonas medium

**Temperature:** 30°C

**Atmosphere:** Anaerobic

## Handling Procedures

1. Put 6 to 8 ml of ATCC Medium #543 into a 13x100 mm screw cap test tube (small). Add 3.0 % cysteine (stock concentration, 0.1 ml per each 5 to 6 ml of medium) and then fill the test tube to capacity with additional #543 broth. Seal the test tube with a screw cap.
2. Let the tube sit at room temperature for 30 minutes before inoculating it with the rehydrated culture.

3. Open the freeze-dried vial according to enclosed instructions.
  4. Aseptically take 0.5 ml of the pre-reduced medium and rehydrate the entire pellet.
  5. Transfer the rehydrated pellet back into the screw cap test tube and close tightly. (The test tube should be filled to capacity).
  6. Incubate the culture at 26-30°C under a tungsten lamp.
  7. Once growth has been established (five to seven days), the culture should be transferred to fresh broth. If a large inoculum is used (10-20%) the medium does not need to be pre-reduced.

**Notes**

Cells are rod shaped some with a slight curve. The cells are motile. Dense suspensions of the cells are green in color, as the culture ages, the color turns to dirty brown-green.
