### Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate an additional broth tube, a #3 agar slant and/or a plate.

5. Incubate all tubes and plate at 37°C for 24 hours.

## Notes

On #3 plates, two colony types are observed: a) smooth, compact, entire, and translucent, and b) flat, irregular, and grainy.
