## **Handling Procedures**

1. Open vial according to enclosed instructions.
2. From a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.6 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.

3. Use 0.5ml of this suspension to inoculate a #196 slant and 0.1ml to inoculate #196 plates.

**4. Incubate tubes and plates at 26°C, under aerobic conditions, for 14-16 days.**

5. After 14-16 days of incubation, wash cells from the slant and transfer this broth to a new slant and plate. Incubate another 14-16 days under aerobic conditions. This second transfer and incubation is necessary for complete removal of the cryoprotectant, which can inhibit growth.
