## Handling Procedures

1. Open vial according to enclosed instructions.
- 2. Using a single tube of #2739 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
- 4. Use several drops of the suspension to inoculate a #2739 agar slant and/or plate.**

5. Incubate the tubes and plate at 50°C for about 1 week.

---

## Notes

In #2739 broth, clumps of cells appear throughout the broth, and they are off white in coloration. This item embeds itself in the agar, so for harvesting purposes, this item needs to be grown in broth. On #2739 agar, colonies are raised, white, aerial mycelium that are fuzzy in appearance.
