Handling Procedures

1. Open vial according to enclosed instructions.
- 2. Using a single tube of #1395 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
- 4. Use several drops of the suspension to inoculate a #173 or #90 agar slant and/or plate.**

5. Incubate the tubes and plate at 37°C for one week.

Notes

Two colony types are observed on #173 agar plates: a) small, irregular, undulate, raised, dull, opaque, and rough; and b) large, entire, circular, smooth, glistening, and low convex. Both types become yellow with age.
