Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

ATCC Medium 0196: Yeast malt extract medium ISP #2

**Temperature:** 26°C

**Atmosphere:** Aerobic

## **Handling Procedures**

1. Open vial according to enclosed instructions.
- 2. Using a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**

4. Use several drops of the suspension to inoculate a #196 agar slant and/or plate.
  5. Incubate the tubes and plate at 26°C for 4 to 7 days.

### **Notes**

Colonies on #196 agar are rough, irregular, wrinkled, dry, entire, and convex. The aerial mycelium is abundant white. The substrate mycelium is medium to dark orange.

This strain is cited to produce netropsin congoicidine (1,7).
