## Handling Procedures

1. Open vial according to enclosed instructions.
  2. Using a single tube of #1877 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #196 agar slant and/or plate.
  5. Incubate the tubes and plate at 26°C for 7 to 10 days.

## Notes

On yeast-malt agar (#196), aerial mycelium are in the yellow or red color series appearing eggshell or light ivory in color. Substrate mycelium produce a yellow-brown pigment.
