Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

ATCC Medium 1490: Modified chopped meat medium

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Atmosphere: Anaerobic

Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Under anaerobic conditions aseptically rehydrate the entire pellet with approximately 0.5 mL of #1490 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #1490 broth. Additional test tubes can be inoculated by

transferring 0.5 mL of the primary broth tube to these secondary broth tubes. Best practice dictates the use of pre-reduced media.

3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #1490 agar slant.
4. Incubate in an anaerobic atmosphere at 37°C for 48 to 72 hours. Incubate one agar plate aerobically at 37°C to check for contamination.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar\
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

Notes

Anaerobe Systems Brucella Blood Plate (AS-111 or AS-141) can be used to analyze colony morphology and purity.

Colonies on Brucella agar are small, entire, glistening, circular, smooth, and low convex.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions.
