ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### Handling Procedures

1. Open vial according to enclosed instructions.

2. From a single tube of #611 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.

3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.

4. Use several drops of this suspension to inoculate an additional broth tube, an agar

slant and/or a plate.

5. Incubate the tubes and plate at 37°C for 24 to 48 hours.

#### Notes

Colonies are circular, with entire margin, convex elevation, and smooth surface. Cells are non-motile, short rods occurring singly, in pairs and small clumps. Broth is cloudy with a pellicle at the surface and smooth sediment with some granules. Brain Heart Infusion (Difco 0037) and Trypticase Soy Agar (BBL 11043) with 5% Defibrinated Sheep Blood will support growth of this strain.
