*Bacillus* sp. strain E601 is a whole-genome sequence bacterium with applications as an ionizing radiation-sterilization control. This strain is recommended by ATCC for use in the tests described in U.S. Pharmacopeia where only the taxon is specified.

**Temperature:** 30°C**Atmosphere:** Aerobic

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.

5. Incubate the tubes and plate at 30°C for 24 hours.

**Notes**

On #18 plates, two colony types are observed: a) translucent, erose, irregular, raised, dull; and b) opaque, smooth, entire, glistening, circular, and raised.
