### Growth Conditions

**Medium:**

ATCC Medium 1869: PRAS-PYG with Tween 80

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

**Temperature:** 37°C**Atmosphere:** Anaerobic

### Handling Procedures

1. Open thawed vial.
2. Under anaerobic conditions aseptically transfer the entire contents to a 5-6 mL tube of #1869 broth. Additional test tubes can be inoculated by transferring 0.1 mL of the primary broth tube to each of the secondary broth tubes. Best

practice dictates the use of pre-reduced media.

3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
4. Incubate in an anaerobic atmosphere at 37°C for 48-72 hours. Incubate one agar plate aerobically at 37°C to check for contamination.

**ANAEROBIC CONDITIONS:**

- Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

---

**Notes**

This culture may require growth to be established in broth before growth on agar can be achieved.

Brucella Blood plates (AS-111 or AS-141) can be used for growth and colony morphology.

For best anaerobic growth, use freshly prepared #260 agar or store freshly prepared media under anaerobic conditions prior to use. Medium #1869 contains resazurin. Resazurin is a color indicator for anaerobic conditions. Observance of pink color in medium before use or during incubation shows anaerobic conditions have not been met and oxidation has occurred. Medium should be discarded.
