## Growth Conditions

ATCC Medium 1237: Modified peptone-yeast extract glucose (MPYG)

**Temperature:** 37°C

## Handling Procedures

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Under anaerobic conditions aseptically rehydrate the entire pellet with approximately 0.5 mL of #1237 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #1237 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.

Best practice dictates the use of pre-reduced media.

3. Use several drops of the primary broth tube to inoculate a Brucella plate.
4. Incubate in an anaerobic atmosphere at 37°C for 48-72 hours. Incubate one agar plate aerobically at 37°C to check for contamination.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

## Notes

This strain will also grow in an atmosphere of 80% N<sub>2</sub>-10% CO<sub>2</sub>-10% H<sub>2</sub>.

Anaerobe Systems Brucella Blood Agar (AS-111) should be used to analyze colony morphology and purity. This item does not grow well on #260.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions. Resazurin in the media is a color indicator for anaerobic conditions. Observance of pink color in medium before use or during incubation shows anaerobic conditions have not been met and oxidation has occurred. Medium should be discarded
