Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

**Culture maintenance:**

1. When the culture is at or near peak density, vigorously agitate the culture.
2. Transfer approximately 0.10 ml to a fresh tube containing 5 ml of fresh ATCC medium 1034.
3. Incubate upright at 25°C with caps screwed on tightly.

4. Transfer every 14 days.
