Handling Procedures

1. Open thawed vial.
 2. Aseptically transfer the entire contents to a 5-6 mL tube of #1378 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.
 3. Use several drops of the primary broth tube to inoculate a #1378 plate and/or #1378 agar slant.
 4. Incubate at 37°C for 24-48 hours in an atmosphere of 5% CO₂.
