Handling Procedures

1. Open the vial according to enclosed instructions.
 2. From a tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 with a sterile pipette; add this medium to the vial to rehydrate the entire pellet.
 3. Aseptically transfer the contents of the vial into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
 5. Incubate all tubes and plate at 37°C for 24 hours.
