1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
  2. Rehydrate the entire pellet with approximately 0.5 mL of #1108 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #1108 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
  3. Use several drops of the primary broth tube to inoculate a #1108 plate and/or #1108 agar slant.
  4. Incubate at 15°C for 5 to 10 days.
