Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #1099 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #1099 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary

- broth tube to these secondary broth tubes.
3. Use several drops of the primary broth tube to inoculate a #1099 plate and/or #1099 agar slant.
 4. Incubate at 37°C for 48 to 72 hours in an atmosphere of 5% CO₂.

Notes

Legionella species are nutritionally fastidious and are inhibited by media of poor caliber, so strict attention should be paid to the quality of the ingredients. The pH of the medium should be checked when cool, and is most critical. Unbuffered medium should not be used. Exposure of medium to light, particularly when hot, may also result in the accumulation of peroxides which can be inhibitory to the bacteria. Before rehydration, vials may be stored at + 2°C to + 8°C for extended periods with minimal loss of viability. Subculturing to maintain culture is discouraged because of the possibility of mutation, selection of variants, or contamination. To minimize changes, it is recommended that cells be harvested and stored at 70°C or colder. Additional information on this culture is available on the ATCC® web site at www.atcc.org.
