Legionella longbeachae strain Long Beach 4 [NCTC 11477] is a whole-genome sequenced bacterial type strain that was isolated from a human lung. This bacterial culture can be used in bioinformatics.

ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Medium:

ATCC Medium 1099: CYE (Charcoal Yeast Extract) Buffered Medium

Temperature: 37°C

Atmosphere: 95% Air, 5% CO₂

Handling Procedures

1. Open vial.
2. Using a single tube of #1099 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #1099 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 2 to 4 days in an atmosphere of 5% CO₂. Loosen the screw caps during the incubation.

Notes

Legionella species are nutritionally fastidious and are inhibited by media of poor caliber, so strict attention should be paid to the quality of the ingredients. The pH of the medium should be checked when cool, and is most critical. Unbuffered medium should not be used. Exposure of medium to light, particularly when hot, may also result in the accumulation of peroxides which can be inhibitory to the bacteria.

Before rehydration, vials may be stored at 2°C to 8°C for extended periods with minimal loss of viability. Subculturing to maintain culture is discouraged because of the possibility of mutation, selection of variants, or contamination. To minimize changes, it is recommended that cells be harvested and stored at -70°C or below.
