### **Handling Procedures**

1. Open vial according to enclosed instructions.
2. Using a single tube of #1209 (5 to 6 mL), withdraw 0.5 to 1.0 mL with a Pasteur

- or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #1209 agar slant and/or plate.
  5. Incubate tubes and plates at 30°C for 24 hours.

## **Notes**

This strain may require a jump start.

Serotype H3:3a,3b (Barjec and Lemille, J. Invertebr. Pathol. 15: 139-140, 1970).

This strain produces spores and toxic parasporal crystals (Johnson *et al.*, Can. J. Microbiol. 26: 486-491, 1980).

This strain also has genes that code for entomocidal proteins (Yamamoto, Curr. Microbiol. 17: 5-12, 1988).
