The pneumococcal powder type 4 (10 mg) is a component of the current 13-valent vaccine against *Streptococcus pneumoniae*. The pneumococcal polysaccharide type 4 can be used to assay for type-specific antibodies, research immune responses, and study immunodeficiencies.

Handling Procedures

1. Prepare a 2 mg/mL pneumococcal polysaccharide stock solution by adding 1 mL of pyrogen-free distilled water (or other buffer of choice) to 2 mg of pneumococcal polysaccharide.
 2. Incubate the suspension for up to two hours at 28°C with gentle stirring on a stir plate to dissolve the polysaccharide.
 3. Aliquot the polysaccharide solution and store at -60°C to -80°C.
