Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Medium:

ATCC Medium 416: Lactobacilli MRS Agar/Broth

Temperature: 37°C

Atmosphere: 95% Air, 5% CO₂

Handling Procedures

1. Open vial.
2. Rehydrate the entire pellet with approximately 0.5 mL of #416 broth.
Aseptically transfer the entire contents to a 5-6 mL tube of #416 broth.
Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.

3. Use several drops of the primary broth tube to inoculate a #416 plate and/or #416 agar slant.
 4. Incubate at 37°C for 24-48 hrs in an atmosphere of 5% CO₂.

Notes

The CO₂ is not required for growth, but may be helpful. This strain also dies off rapidly in broth culture.
