### Medium:

ATCC Medium 2853: Nutrient Agar/Broth with 100 mcg/ml Ampicillin

**Temperature:** 37°C

## Handling Procedures

1. Open vial.
2. Rehydrate the entire pellet with approximately 0.5 mL of # 2853 broth.

Aseptically transfer the entire contents to a 5-6 mL tube of # 2853 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a # 2853 plate and/or #2853 agar slant.
  4. Incubate at 37°C for 24 hours.
