Handling Procedures

***Actinomadura pulveraceus* Iwami et al.**

1. Open vial according to enclosed instructions.
 2. From a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a second tube of broth, a slant and/or a plate.
 5. Incubate all tubes and plate at 26°C for 7 to 10 days.

Notes

Colonies are diffused and circular. Substrate mycelium are off-white pigmented and translucent. White aerial mycelium begins to form only after 21 days incubation.
