For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### Handling Procedures

Frozen ampules packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampules may be stored at or below -70°C. **Do not under any circumstance store frozen ampules at refrigerator freezer temperatures (generally -20°C) for longterm storage.** Long-term storage

of frozen material at this temperature will result in the death of the culture.

1. To thaw a frozen ampule, place it at room temperature or in 30°C water bath, until just thawed (around 1.5 min). Immerse the ampule just sufficient to cover the frozen material.

2. Immediately after thawing, aseptically transfer the culture into a test tube or plate with medium recommended.

3. Incubate the test tube or plate at the temperature recommended.
