Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Growth Conditions

### Medium:

ATCC Medium 1533: GC agar (ATCC Medium 814) with 10 mcg/ml ampicillin

**Temperature:** 37°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #1533 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a # agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 48 hours in an atmosphere of 5% CO<sub>2</sub>.  
Loosen the screw caps during the incubation.

### Notes

Brain Heart Infusion Broth (BD 237500) may be used for rehydration purposes only if #1533 broth is not available, but transfer should immediately be made to #1533 agar. This strain is grown on ampicillin-containing medium to retain the resistance.

This strain is cited to produce plasmid-mediated ROB-1 beta-lactamase which provides ampicillin resistance (1).
