Handling Procedures

1. Open vial according to enclosed instructions.
- 2. Using a single tube of #814 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
- 4. Use several drops of the suspension to inoculate a #814 agar slant and/or plate.**

5. Incubate the tubes and plate at 35°C for 48 hours in an atmosphere of 5% CO₂.
Loosen the screw caps during the incubation period.

Notes

Colonies on #814 agar are small, entire, glistening, circular, smooth, and low convex.
