Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## **Handling Procedures**

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate an additional broth tube, a #44



#### agar slant and/or plate.

- 5. Incubate the tubes and plate at 37°C for 24 hours.
- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #44 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for 24 hours.

#### Notes

Two colony types observed on #44 agar are a) small, entire, circular, raised, smooth, and opaque; b) entire, dull, circular, low convex, and smooth.
