### **Handling Procedures**

- 1. Open vial according to enclosed instructions.**
  - 2. Using a single tube of #1741 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.**
  - 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
  - 4. Use several drops of the suspension to inoculate a #1741 agar slant and/or plate.**
  - 5. Incubate the tubes and plate at 30°C for 72 hours.**

## Notes

This strain is maintained on Medium #1741 to retain the ability to degrade phenol. Colonies are slightly irregular and slightly rough. Growth is slow and sparse. It grows well on Tryptic Soy Agar as entire, smooth, glistening, and convex colonies.
